

**The Parochial Elections (St Martin and the Vale)
Regulations, 2019**

13th December, 2019

Coming into operation

13th December, 2019

THE STATES' ASSEMBLY & CONSTITUTION COMMITTEE, in exercise of the powers conferred on it by section 54(4) of the Reform (Guernsey) Law, 1948^a and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Elections to be held for the office of Douzenier in St Martin and the Vale.

1. (1) An electors' meeting shall take place at the Parish Hall, La Grande Rue, St Martin at 6pm on 18 December, 2019 to elect Russell Clark and David Beausire to the office of Douzenier in the Parish of St Martin.

(2) An electors' meeting shall take place at the Vale Douzaine Room, Maraitaine Road, Vale at 6.30pm on 18 December, 2019 to elect John Niles and Victoria Robinson to the office of Douzenier in the Parish of the Vale.

(3) For the avoidance of doubt, paragraphs (1) and (2) have effect

notwithstanding any previous announcement made in the "Gazette Officielle" or elsewhere fixing dates and times for those elections different from the date and times specified in those paragraphs.

Modification of Article 55 of the Reform Law to elections under these Regulations.

2. (1) Article 55 (notice of elections) shall apply to the elections to be held under regulation 1 subject to the following modification.

(2) For "an election" substitute "the elections to be held under regulation 1 of the Parochial Elections (St Martin and the Vale) Regulations, 2019", and for "not less than fourteen days in advance" to the end, substitute "on or before 15 December, 2019, by –

(a) announcements made in prominent places on the website of each Parish, and

(b) notices placed in the windows of, and in prominent places inside –

(i) in the case of the elections relating to the office of Douzenier in the Parish of St Martin, the Parish Hall of the Parish of St Martin, and


(ii) in the case of the elections relating to the office of Douzenier in the Parish of the Vale, the Vale Douzaine Room,

specifying the date, time and place of the electors' meeting in each Parish, and containing particulars of the nominations received."

Citation and commencement.

3. These Regulations may be cited as the Parochial Elections (St Martin and the Vale) Regulations, 2019 and shall come into force on the day they are made.
