THE STATES OF ALDERNEY POLICY AND FINANCE COMMITTEE, in exercise of the powers conferred on it by article 1 of the Import and Export (Control) (Alderney) Law, 1946^a and of all other powers enabling it in that behalf, hereby makes the following order:-

Amendments to Import Order.

1. (1) The Import (Control) (Alderney) Order, 2010^b is amended as follows.
 - (2) In Schedule 8 –
 - (a) in the opening words of paragraph 6, after "following" insert "originating in any other part of the British Islands",
 - (b) at the end of paragraph 6(e), insert "(with the exception of milk within the meaning of section 1 of the Milk (Control) (Guernsey) Ordinance, 2016)",

(c) in paragraph 7, after "animal" insert "originating in any other part of the British Islands", and

(d) for paragraph 8 substitute –

"8. Any other animals or goods (within the meaning of Article 3 of Preserved Regulation (EU) 2017/625), other than food or feed (with the exception of milk within the meaning of section 1 of the Milk (Control) (Guernsey) Ordinance, 2016), originating outside the British Islands except where imported under and in accordance with Preserved Regulation (EU) 2017/625.", and

(e) for paragraph 17 substitute –

"17. Dangerous products within the meaning of the General Product Safety Regulations (U. K. S. I. 2005/1803)".

(3) In the Interpretation section of Schedule 8, after **"parlour pot"**, insert–

"Preserved Regulation (EU) 2017/625" means Regulation (EU) 2017/625 of the European Parliament and of the Council of 15 March 2017 on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products, amending Regulations (EC) No 999/2001, (EC) No 396/2005, (EC) No 1069/2009, (EC) No 1107/2009, (EU) No 1151/2012, (EU) No 652/2014, (EU) 2016/429 and (EU) 2016/2031 of the European Parliament and of the Council, Council Regulations (EC) No 1/2005 and (EC) No 1099/2009 and Council Directives 98/58/EC, 1999/74/EC, 2007/43/EC, 2008/119/EC and 2008/120/EC, and repealing Regulations (EC) No 854/2004 and (EC) No 882/2004 of the European Parliament and of the Council, Council Directives 89/608/EEC, 89/662/EEC, 90/425/EEC, 91/496/EEC, 96/23/EC, 96/93/EC and 97/78/EC

and Council Decision 92/438/EEC (Official Controls Regulation), as it forms part of Preserved EU law,".

Citation.

2. This Order may be cited as the Import (Control) (Alderney) (Amendment) Order, 2020.

Commencement.

3. This Order comes into force on exit day; and for this purpose "**exit day**" has the meaning given by section 12(1) of the European Union (Brexit) (Bailiwick of Guernsey) Law, 2018^c.
