**The Motor Vehicles, Licensing and Traffic (Fees)
(Guernsey) Regulations, 2021**

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by sections 2A and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987^a, sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 1987^b, section 4, 5, 8, 9 and 16 of the Registration Marks (Sale and Retention) Ordinance, 1997^c, and all other powers enabling them in that behalf, hereby makes the following Regulations:-

Registration marks.

1. (1) In Article 15(3)(b) of the Ordonnance supplémentaire à l'Ordonnance ayant rapport au Trafic Véhiculaire en cette Île, 1932^d (exchange of registration marks), for "forty four pounds" substitute "£46".

(2) The fees prescribed for the purposes of the Registration Marks (Sale and Retention) Ordinance, 1997^e are as follows –

- (a) in section 4 (acquisition of right of retention), the sum of £92,
- (b) in section 5 (acquisition of right to reserve non-special registration mark), the sum of £92,
- (c) in section 8(1) and (3) (issue of duplicate certificate), the sum of £46,
- (d) in section 9(5)(d) (extension of right), the sum of £92,

and for the purpose of those provisions these Regulations shall be deemed to be an Order of the Committee for the Environment & Infrastructure.

Fees for trade plates.

2. In Article 2(2) of the Ordonnance relative aux Licences de Commerçant accordables à l'égard d'Automobiles en usage dans un but commercial, of 26th November 1932^f, for each reference to "£35" substitute "£39".

Driving licence fees.

3. For the Table in Schedule 3 to the Driving Licences (Guernsey) Ordinance, 1995^g, substitute the Table set out in the Schedule to these Regulations.

Fees for registration.

4. For the Table of Fees in the Schedule to the Motor Taxation and Licensing (Fees) (Guernsey) Regulations, 2007^h substitute the following Table –

1. First registration of motor vehicle	£46
2. Issue of duplicate certificate	£14
3. Subsequent registration of motor vehicle	£29
4. Issue of certificate of export	£14"

5. The Motor Vehicles, Licensing and Traffic (Fees) (Guernsey) Regulations, 2019ⁱ are revoked.

Citation.

6. These Regulations may be cited as the Motor Vehicles, Licensing and Traffic (Fees) (Guernsey) Regulations, 2021.

Commencement

7. These Regulations shall come into force on the 1st June, 2021.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations increase the fees payable with effect from 1st June 2021 in relation to –

- the exchange and retention of registration marks
- trade plate renewals
- the issue and renewal of driving licences and of duplicate licences
- first and subsequent registration of motor vehicles and the issue of duplicate registration certificates and certificates of export.

The increases are generally based on the increases in RPIX since the last review.

These Regulations will come into force on the 1st June, 2021.
