

**The Control of Poisonous Substances (Fees) (Guernsey)  
Regulations, 2021**

THE COMMITTEE FOR EMPLOYMENT AND SOCIAL SECURITY, in exercise of the powers conferred on it by sections 1(2)(g) and 4 of the Poisonous Substances (Guernsey) Law, 1994<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Fees payable under Poisonous Substances Law.**

1. (1) The table below specifies the fees payable under and for the purposes of the Poisonous Substances (Guernsey) Law, 1994 ("the Law") and the Control of Poisonous Substances (Guernsey) Regulations, 2014<sup>b</sup> ("the Regulations").

(2) Column 1 sets out the provision of the Law or Regulations under and for which purpose the fee is payable, column 2 sets out the matter for which the fee is payable and column 3 sets out the fee payable.
