THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred on it by 79 as read with section 15 and 20(1A) of the Customs and Excise (General Provisions) (Bailiwick of Guernsey) Law, 1972^a, and all other powers enabling them in that behalf, hereby orders:-

Amendment of the 2020 Export Declarations Regulations

1. (1) The Customs and Excise (Customs Export Declarations) Regulations, 2020^b are amended as follows.

“(e) such goods as may be specified by the Chief Officer of Customs and Excise in a public notice, which are subject to a temporary admission procedure at the time of making the export declaration where the person making the export declaration is a qualifying traveller who made, or was otherwise capable of making, the Customs declaration for that procedure orally in accordance with regulations 9 and 11 of the Customs and Excise (Import) (Customs Declarations) Regulations 2020^c”.

Citation.

2. These Regulations may be cited as the Customs and Excise (Customs Export Declarations) (Amendment) Regulations, 2021.

Commencement.

3. These Regulations shall come into force on the day on which they are made.
