**The Control of Intoxicating Liquor (Designated Public Places) (North Show Boundaries) Order, 2021**

*Made* 2<sup>nd</sup> August, 2021

*Coming into operation* 25<sup>th</sup> August, 2021

THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred upon it by section 2(1) and (2) of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007<sup>a</sup>, as amended, hereby orders:-

1. In order to prevent nuisance or annoyance to members of the public or a section of the public or disorder which is likely to be associated with the consumption of intoxicating liquor in that place, the area of the parish of Castel marked in red on the attached plan, that is:-

- (a) Route de Sausmarez, from the Haye du Puits Junction to the Ruelle du Villocq Junction,
- (b) Route de Cobo, from the Haye du Puits Junction to the junction of Le Douit Boudin,
- (c) Ruelle des Sausmarez,
- (d) La Pouquelah,

- (e) La Rue Traversee,
- (f) Rue des Houmets,
- (g) Rue des Emrais,
- (h) Ruelle de la Tour,
- (i) The Saumarez Park Nature Trail, and
- (j) The Home Farm Field.

shall be a designated public place for the purpose of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007 during the hours and days specified in article 2.

2. The area specified in article 1 shall be a designated public place between midday and midnight on Wednesday 25<sup>th</sup> August and between midday and midnight on Thursday 26<sup>th</sup> August 2021.

3. This Order may be cited as the Control of Intoxicating Liquor (Designated Public Places) (North Show Boundaries) Order, 2021 and shall come into force on the 25<sup>th</sup> August, 2021.

EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order sets out the area of Castel to be designated as a Designated Public Place under the provisions of Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007, between midday and midnight on Wednesday 25<sup>th</sup> August and between midday and midnight on Thursday 26<sup>th</sup> August 2021.

This Order comes into force on the 25<sup>th</sup> August, 2021.
