**The Control of Intoxicating Liquor (Designated Public
Places) (Vale Castle) Order, 2021**

Made 2nd August, 2021

Coming into operation 29th August, 2021

THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred upon it by section 2(1) and (2) of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007^a, as amended, hereby orders:-

1. In order to prevent nuisance or annoyance to members of the public or a section of the public or disorder which is likely to be associated with the consumption of intoxicating liquor in that place, the area of the parishes of Vale and St Sampson's marked in red on the attached plan, that is:-

- (a) Castle Road to the junction with Rue des Barras,
- (b) North Quay, North Pier and its environs, Abraham's Bosum,
- (c) North Side; Bank Lane, Trafalgar Road, Trafalgar Lane, Les Monmains, Longree, and
- (d) The Bridge,

shall be a designated public place for the purpose of the Control of Intoxicating

Liquor (Designated Public Places) Ordinance, 2007 during the hours and days specified in article 2.

2. The area specified in article 1 shall be a designated public place between midday and midnight on Sunday 29th August 2021.

3. This Order may be cited as the Control of Intoxicating Liquor (Designated Public Places) (Vale Castle) Order, 2021 and shall come into force on the 29th August, 2021.

This Order sets out the area of Vale and St Sampson's to be designated as a Designated Public Place under the provisions of Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007, between midday and midnight on Sunday 29th August, 2021.
