THE POLICY & RESOURCES COMMITTEE and the COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY, acting jointly in exercise of the powers conferred on them by sections 3 and 4 of the States (Reform) (Guernsey) Law, 2015<sup>a</sup>, and all other powers enabling them in that behalf, hereby makes the following Regulations:-

**Performance of functions relating to investment of monies in Guernsey Health Service Fund.**

1. (1) Pursuant to an arrangement under section 3 of the States (Reform) (Guernsey) Law, 2015, the functions of the States Committee for Employment & Social Security under section 1(7) and (8) of the Health Service

(Benefit) (Guernsey) Law, 1990<sup>b</sup> shall be performed by the States Policy & Resources Committee.

**Committee for Employment and Social Security may not continue to exercise the functions.**

2. For the purposes of section 3(4)(b) of the States (Reform) (Guernsey) Law, 2015, the Committee for Employment & Social Security may not continue to exercise the functions referred to in regulation 1 while these Regulations remain in force.


**Citation.**

3. These Regulations may be cited as the States Reform (Performance of Functions) (Guernsey Health Service Fund) Regulations, 2021.

**Commencement**

4. These Regulations shall come into force on the 2<sup>nd</sup> September, 2021.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations make provision, for the purposes of section 3 of the States Reform (Guernsey) Law, 2015, for the investment functions of the Committee for Employment & Social Security relating to the monies held in the Guernsey Health Service Fund, under section 1(7) and (8) of the Health Service (Benefit) (Guernsey) Law, 1990, to be exercised by the Policy & Resources Committee.

It is intended that those investment functions will be performed by a sub-committee of the Policy & Resources Committee. The arrangement is intended to be a temporary one put in place until the planned closure of the Guernsey Health Service Fund and repeal of the functions in relation to which the arrangement is made. This will occur

following the coming into force of the Health Service Benefit (Amendment and Miscellaneous Provisions) (Guernsey) Law, 2021.

These Regulations come into force on the 2<sup>nd</sup> day of September, 2021.
