**The Boarding Permit Fees Order, 2021**

*Made*

*9<sup>th</sup> December, 2021*

*Coming into operation*

*1<sup>st</sup> April, 2022*

*Laid before the States*

THE COMMITTEE *for* ECONOMIC DEVELOPMENT, in exercise of the powers conferred on it by section 17 of the Tourist Law, 1948<sup>a</sup> as amended<sup>b</sup> and all other powers enabling it in that behalf, hereby orders:-

**Fee payable by applicants for a boarding permit.**

1. An applicant for a boarding permit shall pay to the Committee on application for a permit valid from 1<sup>st</sup> April 2022 to 31<sup>st</sup> March 2023, or part thereof, the following fee -

- a) for an application in respect of accommodation to be provided in premises which would be categorised as a hotel, guest accommodation, serviced apartment or self-catering premises where a boarding permit to be granted under the Law, the sum of £8.50 per person inscribed on each application submitted, or

- b) for an application in respect of accommodation to be provided in premises of any description not falling within subparagraph (a), the sum of £50.00 per permit application submitted.

**Interpretation.**

2. In this Order, unless the context requires otherwise the “Committee” means the Committee *for* Economic Development.

**Revocation.**

3. The Boarding Permit Fees (No. 2) Order, 2020<sup>c</sup> is revoked.

**Citation.**

4. This Order may be cited as the Boarding Permit Fees Order, 2021.

**Commencement.**

5. This Order comes into force on the 1<sup>st</sup> April, 2022.
