The following report from the Committee of Council for the Affairs of Jersey and Guernsey was today read at the Board:

“In accordance with Your Majesty’s General Order of Reference of 22nd February 1952 the Committee have considered a Petition of the States of Guernsey:

“That, in pursuance of their Resolution of 29th May 2015, the States of Deliberation at a meeting on 15th July 2021 approved a *Projet de Loi* entitled the Public Thoroughfares (Guernsey) (Amendment) Law, 2021 and requested the Bailiff to present a most humble Petition to Your Majesty in Council praying for Your Royal Sanction to it. That the *Projet de Loi* is as set forth in the attached Schedule. The Petition most humbly prays that Your Majesty might be graciously pleased to sanction the Public Thoroughfares (Guernsey) (Amendment) Law, 2021, and to order that it shall have force of law in the Island of Guernsey.

“The Committee have considered the *Projet de Loi* and have agreed to report that it may be advisable for Your Majesty to approve and ratify it”.

Her Majesty, having taken the report into consideration, was pleased, by and with the advice of Her Privy Council, to approve and ratify the *Projet de Loi* (a copy of which is annexed to this Order) and to order that it, together with this Order, shall have the force of law in the Island of Guernsey and shall be entered on the Register of the Island of Guernsey and observed accordingly.

Her Majesty’s Officers in the Bailiwick of Guernsey, and all others whom it may concern, are therefore to take notice of Her Majesty’s Order and to proceed accordingly.

PROJET DE LOI

ENTITLED

The Public Thoroughfares (Guernsey) (Amendment) Law, 2021

THE STATES, in pursuance of their Resolution of the 29th May, 2015^a, have approved the following provisions which, subject to the Sanction of Her Most Excellent Majesty in Council, shall have force of law in the Island of Guernsey.

Amendment of the 1958 Law.

1. (1) In section 1 of the Public Thoroughfares (Guernsey) Law, 1958^b ("**the 1958 Law**"), after the definition of "the Committee" insert the following definition –

"the Electricity Company" means "Guernsey Electricity Limited" whose registered office is at Electricity House, North Side in the Parish of Vale,".

(2) For the heading of section 5 substitute "**Telecommunication licensees, Electricity Company and Gas Company.**".

(3) In the first paragraph of section 5 of the 1958 Law, after "granted or deemed to have been granted under that Law" insert ", the Electricity Company".

(4) In section 5(b) of the 1958 Law –

(a) after "in the case of" insert "the Electricity Company or",
and

(b) after "mains" insert ", service cables".

Extent.

2. This Law shall extend to the Island of Guernsey.

Citation.

3. This Law may be cited as the Public Thoroughfares (Guernsey) (Amendment) Law, 2021.

Commencement.

4. This Law shall come into force on the day of its registration on the records of the Island of Guernsey.
