**The Parking Places Order, 2022**

*Made*

*7<sup>th</sup> March, 2022*

*Coming into operation*

*21<sup>st</sup> March, 2022*

**THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE**, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963<sup>a</sup>, and all other powers enabling them in that behalf, hereby order:-

**Amendments to 1991 Order.**

1. The Parking Places Order, 1991<sup>b</sup> ("the 1991 Order") has been amended as follows.

2. In Part A of Schedule 1 to the 1991 Order, in the third column of the entry relating to disc parking place No. DA3, for "Approved Parking Places Nos. AC33 and AD2" substitute "Disc Parking Place No. DC50 and Approved Parking Place No. AD2".

3. In Part B of Schedule 1 to the 1991 Order, in the third column of the entry relating to disc parking place No. DB14, for "AA2, AB20 and AC77" substitute "AA2 and AB20".

4. In Part C of Schedule 1 to the 1991 Order –

- (a) in the third column of the entry relating to disc parking place No. DC2, after "inclusive" insert "but excluding Disc Parking Place No. DC3",
- (b) in the third column of the entry relating to disc parking place No. DC3, insert "The southern portion of the seaward side of the road between the rock outcrop to the south of the Horseshoe Pool and the entrance to the Mixed Bathing Pool, as indicated by signs.",
- (c) in the third column of the entry relating to disc parking place No. DC13, after "AC33" insert "and AC34", and
- (d) in the third column of the entry relating to disc parking place No. DC19, after "DA14" insert "and Approved Parking Place No. AC87".

5. In Part E of Schedule 1 to the 1991 Order, in the third column of entry relating to disc parking place No. DE1, after "inclusive" insert "but excluding Disc Parking Place No. DC3".

6. In Part A of Schedule 2 to the 1991 Order –

- (a) in the third column of the entry relating to Approved Parking Place No. AA11a, for "AC36" substitute ", AB36b",
- (b) in the third column of the entry relating to Approved Parking Place No. AA76, after "estates" insert "but excluding Approved Parking Place No. AC88", and

- (c) in the third column of the entry relating to Approved Parking Place No. AA89, after "estate" insert "excluding Approved Parking Place No. AC86".

7. In Part C of Schedule 2 to the 1991 Order –

- (a) after the entry relating to Approved Parking Place No. AC1d, insert –

"AC1	Rosaire Avenue	The portion of the road as near as may be to The Elms, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.",
------	----------------	---

- (b) after the entry relating to Approved Parking Place No. AC33, insert –

"AC34	Sausmarez Street	The portion of the road as near as may be to No. 30, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.",
-------	------------------	---

- (c) the entry relating to Approved Parking Place No. AC77 is deleted,

- (d) after the entry relating to Approved Parking Place No. AC85, insert –

"AC86	Jardin de l'Epine	The portion of the road as near as may be to No. 7, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC87	Gategny Esplanade	The portion of the road as near as may be to Bosq Lane, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC88	Rue Flere	The portion of the road as near as may be to the Old Farm, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

**Citation and commencement.**

8. This Order may be cited as the Parking Places (Amendment) Order, 2022 and shall come into force on the 21<sup>st</sup> March, 2022.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order amends the Parking Places Order, 1991. It changes an area of seasonally-changed two hour/ten hour Disc Parking to permanent two hour disc parking; it removes an accessible parking space which is no longer required from the Ville au Roi and from Gibauderie; and it creates additional accessible parking spaces for blue badge holders in Sausmarez Street, Rosaire Avenue, Gategny Esplanade, Rue Flere and Jardin de l'Epine. The Order also correct two minor errors in the 1991 Order.

This Order will come into force on the 21<sup>st</sup> March, 2022.
