(Amendment No. 3) Order, 2022**

THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred on it by sections 67A, 67B and 67C of the Immigration Act 2014^a as extended to the Bailiwick by the Immigration (Guernsey) Order 2016^b, section 33(1) of the Immigration Act 1971^c as extended to the Bailiwick by the Immigration (Guernsey) Order 1993^d, and all other powers enabling it in that behalf, hereby orders:-

Amendment of the 2019 Order.

1. The Immigration (Fees) (Bailiwick of Guernsey) Order, 2019^e ("the **principal Order**") is amended as set out in articles 2, 3 and 4.

2. In article 1 of the principal Order –

(a) in paragraph (1) –

(i) in subparagraph (b), for "or Appendix EU leave", substitute ", Appendix EU leave or Appendix Ukraine Scheme leave", and

(ii) in subparagraph (c), for "or of Appendix EU leave", substitute ", of Appendix EU leave or of Appendix Ukraine Scheme leave", and

(b) in paragraph (5), for subparagraph (a), substitute the following subparagraphs –

"(a) Appendix EU leave, or

(aa) Appendix Ukraine Scheme leave,".

3. In article 5(1) of the principal Order, immediately after the definition of "**Appendix EU leave**", insert the following definition –

"Appendix Ukraine Scheme leave" means leave to enter or remain granted by virtue of Appendix Ukraine Scheme to the Immigration (Bailiwick of Guernsey) Rules, 2008,".

4. In the Schedule to the principal Order, in the table heading "*Applications for Leave to Remain, other than Appendix EU Leave*", immediately after "*EU Leave*", insert "*or Appendix Ukraine Scheme Leave*".

Citation.

5. This Order may be cited as the Immigration (Fees) (Bailiwick of Guernsey) (Amendment No. 3) Order, 2022.

Commencement

6. This Order shall come into force on 8th April, 2022.

EXPLANATORY NOTE

This Order amends the Immigration (Fees) (Bailiwick of Guernsey) Order, 2019 to effectively exempt applications for leave to enter or remain under Appendix Ukraine Scheme from fees that would normally be payable for such applications.

This Order will come into force on 11th April, 2022.
