The Parking Places (Amendment) (No. 2) Order, 2022

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963^a, and all other powers enabling them in that behalf, hereby order:-

Amendments to 1991 Order.

1. The Parking Places Order, 1991^b ("**the 1991 Order**") is amended as follows.

2. In Part C of Schedule 1 to the 1991 Order, in the third column of the entry relating to disc parking place No. DC33, after "Grange Road" insert ", but excluding Approved Parking Place No. AC77".

3. In Part A of Schedule 2 to the 1991 Order -

(a) in the third column of the entry relating to Approved Parking Place No. AA24, delete "but excluding Approved Parking Place No. AC6b",

- (b) in the third column of the entry relating to Approved Parking Place No. AA56, after "estates" insert ", but excluding Approved Parking Place No. AC70",
- (c) in the third column of the entry relating to Approved Parking Place No. AA81, after "Sir William Place" insert ", but excluding Approved Parking Place No. AC19", and
- (d) in the third column of the entry relating to Approved Parking Place No. AA89, delete "excluding Approved Parking Place No. AC86".

4. In Part C of Schedule 2 to the 1991 Order -

- (a) after the entry relating to Approved Parking Place No. AC5b, insert -

"AC5c	Le Picquerel, Vale	The portion of the road as near as may be to Figtree Cottage, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.",

- (b) the entry relating to Approved Parking Place No. AC6b is deleted,
- (c) after the entry relating to Approved Parking Place No. AC18, insert -

"AC19	Le Truchot	The portion of the south side of the road as near as may be to Edward T Wheadon House, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.",

(d) after the entry relating to Approved Parking Place No. AC69, insert -

"AC70	Route des Coutures Estate	The portion of the road as near as may be to No. 16, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.",

(e) after the entry relating to Approved Parking Place no. AC76, insert -

"AC77	Victoria Road	The portion of the south-west side of the road as near as may be to No. 89, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.",

and

(f) the entry relating to Approved Parking Place No. AC86 is deleted.


Interpretation.

5. In this Order "**the 1991 Order**" means the Parking Places Order, 1991.

6. This Order may be cited as the Parking Places (Amendment) (No. 2) Order, 2022 and shall come into force on the 18th July, 2022.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991. It installs accessible parking spaces in Le Picquerel; Route des Coutures, St Martin's; Victoria Road; and Le Truchot. Accessible parking spaces in Victoria Avenue and Jardin de l'Epine, which are no longer required, are removed.

This Order will come into force on the 18th July, 2022.
