

# The Income Support (Implementation) (Amendment) Ordinance, 2022

THE STATES POLICY & RESOURCES COMMITTEE, in pursuance of the Resolutions of the States of the 8<sup>th</sup> September, 2022<sup>a</sup>, and in exercise of the powers conferred on the States by sections 3(2) and (4), 15, 15A and 15B of the Income Support (Guernsey) Law, 1971<sup>b</sup>, and all other powers enabling them in that behalf and in exercise of the powers conferred on the Committee by Article 66A(1) of the Reform (Guernsey) Law, 1948<sup>c</sup>, hereby order:-

## Amendment of Ordinance.

1. The Income Support (Implementation) Ordinance, 1971<sup>d</sup> ("the Ordinance") is amended as follows.

2. In paragraph 6 (rent) of the First Schedule -

(a) in subparagraph (1)(b), for "£80.50" substitute "£84.50",  
and

(b) in subparagraph (2A)(a), for "£80.50" substitute  
"£84.50".

3. In Table 1 set out in the Appendix to the First Schedule, in the first

column, for "£930.00" substitute "£980.00".

4. For Tables 2 to 4 set out in the Appendix to the First Schedule, substitute the numbered Tables 2 to 4 set out in the Schedule to this Ordinance.

**Extent.**

5. This Ordinance has effect in the islands of Guernsey, Alderney, Herm and Jethou.

**Repeal.**

6. The Income Support (Implementation) (Amendment) (No. 3) Ordinance, 2021<sup>e</sup> is repealed.

**Citation.**

7. This Ordinance may be cited as the Income Support (Implementation) (Amendment) Ordinance, 2022.

**Commencement.**

8. This Ordinance shall come into force on the 7<sup>th</sup> October, 2022.
