The Control of Intoxicating Liquor (Designated Public Places) (State Funeral – Saumarez Park) Order, 2022

Made 16th September, 2022

Coming into operation 19th September, 2022

THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred upon it by section 2(1) and (2) of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007^a, as amended, hereby orders:-

1. In order to prevent nuisance or annoyance to members of the public or a section of the public or disorder which is likely to be associated with the consumption of intoxicating liquor in that place, the area of the parish of Castel hatched in red on the attached plan, known as Saumarez Park, located within the area bounded by the following public highways, but not including the said public highways:-

- (a) Ruelle des Saumarez,
- (b) Route de Saumarez, from its junction with Ruelle de Saumarez to its junction with Route de Cobo,
- (c) Route de Cobo, from its junction with Route de Saumarez to

- its junction with La Pouquelah,
(d) La Pouquelah.

shall be a designated public place for the purpose of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007 during the hours and day specified in article 2.

2. The area specified in article 1 shall be a designated public place on Monday 19th September 2022 between 09:00 and 13:00.

3. This Order may be cited as the Control of Intoxicating Liquor (Designated Public Places) (State Funeral – Saumarez Park) Order, 2022 and shall come into force on the 19th September 2022.


EXPLANATORY NOTE
