**The Income Support (Guernsey) (Amendment)  
Regulations, 2022**

**THE COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY**, in exercise of the powers conferred on it by sections 6A and 15B of the Income Support (Guernsey) Law, 1971<sup>a</sup>, and all other powers enabling it in that behalf, hereby makes the following regulations:-

**Amendment of 2014 Regulations.**

1. The Income Support (Guernsey) Regulations, 2014<sup>b</sup> are amended as follows.

2. In regulation 8(a) -

(a) in item (i), for "£50" substitute "£60", and

(b) in item (ii), for "£100" substitute "£150".

3. For Schedule 2, substitute the Schedule 2 in the Schedule to these Regulations.

**Extent.**

4. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

**Citation.**

5. These Regulations may be cited as the Income Support (Guernsey) (Amendment) Regulations, 2022.

**Commencement.**

6. (1) These Regulations (with the exception of regulation 3) shall come into force on the 22<sup>nd</sup> November 2022.

(2) Regulation 3 shall come into force on the 6<sup>th</sup> January, 2023.

Regulation 8A

MAXIMUM CAPITAL RESOURCES FOR PURPOSES OF PAYMENT OF MEDICAL  
EXPENSES

<i>(1) Category of person</i>	<i>(2) Maximum capital</i>
Single person who has not attained pensionable age	£3,500
Couple, neither of whom has attained pensionable age	£6,000
Single person or couple with one or more children	£6,000
Single person who has attained pensionable age	£6,000
Couple, one or both of whom has attained pensionable age	£8,000

---

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations increase the maximum amount by which a person's weekly household income may exceed their weekly requirements for the person to receive financial support for reasonable medical expenses. Save for regulation 3, they will come into force on 22<sup>nd</sup> November 2022.

Regulation 3 replaces Schedule 2 to the Income Support (Guernsey) Regulations, 2014 and will come into force on the 6<sup>th</sup> January, 2023.
