**The Social Insurance (Benefits) (Amendment)
Regulations, 2022**

THE COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY, in exercise of the powers conferred upon it by sections 15, 20, 31 and 116 of the Social Insurance (Guernsey) Law, 1978^a, and of all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the 2003 Regulations.

1. The Social Insurance (Benefits) Regulations, 2003^b ("the principal Regulations") are amended as follows.
2. The five schedules to the principal Regulations are revoked and replaced by the five schedules set out in the Schedule to these Regulations.

Revocation of 2021 Regulations.

3. The Social Insurance (Benefits) (Amendment) Regulations, 2021^c and the Social Insurance (Benefits) (Amendment) (No. 2) Regulations, 2021^d are revoked.

Citation, commencement and extent.

4. (1) These Regulations may be cited as the Social Insurance (Benefits) (Amendment) Regulations, 2022.

(2) These Regulations shall come into force on the 2nd January, 2023.

(3) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations replace the schedules to the Social Insurance (Benefits) Regulations, 2003 and prescribe the reduced rates of benefit payable from 2nd January, 2023 to claimants who do not satisfy the conditions for entitlement to payment of the maximum rate of benefit.

These Regulations come into force on the 2nd January, 2023.
