**The States Housing (Statutory Tenancies) (Amendment)

THE COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY, in exercise of the powers conferred on it by sections 2, 3 and 5 of the States Housing (Tenancies, Rent and Rebate Scheme) (Guernsey) Law, 2004<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendment of the Statutory Tenancies Regulations.**

1. (1) Schedule 6 to the States Housing (Statutory Tenancies) (Guernsey) Regulations, 2005<sup>b</sup> is amended as follows.

The Property has an enclosed garden	£10.95
The Property has a patio, a balcony, or a patio and a balcony*	£5.48
The Property has shared communal facilities**	£5.48
The Property has an allocated parking space	£10.95
The Property is a house	£10.95

2. These Regulations may be cited as the States Housing (Statutory Tenancies) (Guernsey) (Amendment) Regulations, 2022, and shall come into force on the 1<sup>st</sup> January, 2023.

EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations amend the States Housing (Statutory Tenancies) (Guernsey) Regulations, 2005 ("the Statutory Tenancies Regulations") to update the rates used in the determination of standard weekly rent.

These Regulations come into force on the 1<sup>st</sup> January, 2023.
