The Companies (Alderney) Law (Fees) (Amendment)

THE STATES OF ALDERNEY, in exercise of the powers conferred on them by sections 159 and 164 of the Companies (Alderney) Law, 1994^a, and all other powers enabling them in that behalf, hereby order:-

Amendments to the 1994 Law.

1. (1) The Companies (Alderney) Law, 1994, is amended as follows.
 - (2) In section 107(7) -
 - (a) in paragraph (a), for "£80", substitute "£200",
 - (b) in paragraph (b), for "£160", substitute "£400", and
 - (c) in paragraph (c), for "£240", substitute "£500".

- (3) In section 108(4)(b), for "£240", substitute "£500".
- (4) In section 159(1) -
 - (a) in paragraph (a), for "£120", substitute "£170",
 - (b) in paragraphs (b) and (c), for "£39", substitute "£45",
 - (c) in paragraph (d), for "£26", substitute "£25",
 - (d) in paragraph (e), for "£26", substitute "£45",
 - (e) in paragraphs (f) and (g), for "£61", substitute "£200",
 - (f) in paragraph (h), for "£39", substitute "£30",
 - (g) in paragraph (i), for "£39", substitute "£45",
 - (h) in paragraphs (j) and (k), for "£26", substitute "£45",
 - (i) in paragraph (l), for "£61", substitute "£60", and
 - (j) in paragraph (m), for "£45", substitute "£30".

Amendments to the 2012 Ordinance.

2. (1) Section 4 of the Companies (Alderney) Law (Fees) Ordinance, 2012 is repealed.

(2) Section 5 of the Companies (Alderney) Law (Fees) Ordinance, 2012 is amended as follows -

- (a) in paragraph (a), for "£33", substitute "£45",
- (b) in paragraph (b), for "£33", substitute "£30",

- (c) in paragraphs (c), (d) and (e) for "£33", substitute "£45",
- (d) in paragraphs (f) and (g), for "£33", substitute "£30",
- (e) in paragraph (h), for "£13 per company", substitute "£2 per document with a minimum charge of £10",
- (f) in paragraph (i), for "£1.25", substitute "and for the transmission by the Registrar of an electronic copy of any such document by electronic means, £2.00",
- (g) paragraph (j) is repealed,
- (h) in paragraph (k), for "£26", substitute "£25", and
- (i) for paragraph (l), substitute -

"l) for the supply by the Registrar of a Certificate of Incumbency, £30."

Citation.

3. This Ordinance may be cited as the Companies (Alderney) Law (Fees) (Amendment) Ordinance, 2022.

Commencement.

4. This Ordinance shall come into force on 11th January 2023.
