**The Motor Vehicles, Licensing, Tests and Traffic (Fees)  
(Guernsey) Regulations, 2023**

**THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE**, in exercise of the powers conferred on it by sections 2A and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987<sup>a</sup>, sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 1987<sup>b</sup>, Article 2(2) of the Ordonnance relative aux Licences de Commerçant accordables à l'égard d'Automobiles en usage dans un but commercial, of 26<sup>th</sup> November 1932<sup>c</sup>, section 4A of the Driving Licences (Guernsey) Ordinance, 1995<sup>d</sup>, sections 4, 5, 8, 9 and 16 of the Registration Marks (Sale and

Retention) Ordinance, 1997<sup>e</sup>, and all other powers enabling them in that behalf, hereby makes the following Regulations:-

**Registration marks.**

1. (1) In Article 15(3)(b) of the Ordonnance supplémentaire à l'Ordonnance ayant rapport au Trafic Véhiculaire en cette Île, 1932<sup>f</sup> (exchange of registration marks), for "£46" substitute "£50".

(2) The fees prescribed for the purposes of the Registration Marks (Sale and Retention) Ordinance, 1997 are as follows -

- (a) in section 4 (acquisition of right of retention), the sum of £100,
- (b) in section 5(1) (acquisition of right to reserve non-special registration mark), the sum of £100,
- (c) in section 8(1) and (3) (issue of duplicate certificate of entitlement), the sum of £50,
- (d) in section 9(5)(d) (extension of right), the sum of £100,

and for the purpose of those provisions these Regulations shall be deemed to be an Order of the Committee for the Environment & Infrastructure.

**Fees for trade plates.**

2. In Article 2(2) of the Ordonnance relative aux Licences de Commerçant accordables à l'égard d'Automobiles en usage dans un but commercial, of 26<sup>th</sup> November 1932 -

- (a) for "£39", in both places it appears, substitute "£43", and
- (b) for "£17.50" substitute "£20".

**Driving test and driving licence fees.**

3. In the Driving Licences (Guernsey) Ordinance, 1995 -

- (a) in the table in Schedule 2, in the second column -
  - (i) for "£75", in each place it appears, substitute "£92", and
  - (ii) for "£130", in each place it appears, substitute "£159", and
- (b) for the table in Schedule 3, substitute the table set out in the Schedule to these Regulations.

**Fees for registration.**

4. For the Table of fees in the Schedule to the Motor Taxation and Licensing (Fees) (Guernsey) Regulations, 2007<sup>§</sup> substitute the following table -

**Theory test fees.**

5. In Schedule 1 of the Driving Licences (Theory Test) (Guernsey) Regulations 2016<sup>h</sup>, in Column 2 of the table -

- (a) for "£38", in both places it appears, substitute "£47", and
- (b) for "£54", in both places it appears, substitute "£67".

**Revocation.**

6. The following Regulations are revoked -

- (a) the Driving Tests (Fees) Regulations, 2017<sup>i</sup>, and
- (b) the Motor Vehicles, Licensing and Traffic (Fees)


**Citation.**

(4) A full or provisional licence granted in exchange for a subsisting licence (other than a licence issued by the competent authority in a country outside the Island) or in place of a licence revoked pursuant to section 9(1) of this Ordinance (surrender of driving licences) except -  (a) where the licence granted is a first full	£33	£53	£63



## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations increase the fees payable with effect from 6<sup>th</sup> March 2023 in relation to -

- the exchange and retention of registration marks,
- trade plate renewals,
- the issue and renewal of driving licences and of duplicate licences,
- first and subsequent registration of motor vehicles and the issue of duplicate registration certificates and certificates of export,
- driving tests and theory tests.

The increases are generally based on the increases in RPIX since the last review.

These Regulations will come into force on the 6<sup>th</sup> March 2023.
