**The Control of Intoxicating Liquor (Designated Public Places) (Bus Terminus) Order, 2023**

*17<sup>th</sup> April 2023*

*Coming into operation*

*1<sup>st</sup> May, 2023*

**THE COMMITTEE FOR HOME AFFAIRS**, in exercise of the powers conferred upon it by section 2(1) and (2) of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007<sup>a</sup>, hereby orders:-

1. In order to prevent nuisance or annoyance to members of the public or a section of the public or disorder which is likely to be associated with the consumption of intoxicating liquor in that place, the area of the parish of St Peter Port marked in red on the attached plan, that is: -

- (a) the pedestrianised area of the Bus Terminus located on the South Esplanade, as it extends from the Picquet House, along the bus layby, to the bus park,

shall be a designated public place for the purpose of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007 during the hours and days specified in article 2.

2. The area specified in article 1 shall be a designated public place between 1<sup>st</sup> May 2023 and 12.00 midnight on 31<sup>st</sup> October 2023.

3. This Order may be cited as the Control of Intoxicating Liquor (Designated Public Places) (Bus Terminus) Order, 2023 and shall come into force on the 1<sup>st</sup> May 2023.

#### EXPLANATORY NOTE

*(This note is not part of the Order)*

In order to prevent nuisance or annoyance to members of the public which is likely to be associated with the consumption of intoxicating liquor in that place, this Order sets out the area of St Peter Port to be designated as a Designated Public Place under the provisions of Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007, between 1<sup>st</sup> May 2023 and 12.00 midnight on 31<sup>st</sup> October 2023.

This Order comes into force on 1<sup>st</sup> May 2023.
