THE STATES OF ALDERNEY POLICY AND FINANCE COMMITTEE, in exercise of the powers conferred on it by article 1 of the Import and Export (Control) (Alderney) Law, 1946^a and of all other powers enabling it in that behalf, hereby makes the following order:-

Amendments to Order of 2010.

1. The Import (Control) (Alderney) Order, 2010^b ("**the principal Order**") is amended as follows.

2. Immediately after article 1 of the principal Order, insert the following article -

"Importation of bees and bee-related products from Calabria.

1A. No person shall import any goods specified in Schedule 10."

3. Immediately after Schedule 9 of the principal Order, insert the schedule set out in the Schedule to this Order.

Citation.

4. This Order may be cited as the Import (Control) (Alderney) (Amendment) Order, 2023.

Commencement.

5. This Order shall come into force on the 1st March, 2023.

Article 3

SCHEDULE TO BE INSERTED IN THE IMPORT (CONTROL) (ALDERNEY) ORDER, 2010

"SCHEDULE 10

Article 1A

GOODS THAT CANNOT BE IMPORTED

Bees and related products from the Region of Calabria, Italy.

1. Any of the following originating in or dispatched from the Region of Calabria, Italy -

- (a) honeybees,
- (b) bumble bees,
- (c) unprocessed apiculture by-products,
- (d) used beekeeping equipment, or
- (e) apiculture products in honeycomb intended for human consumption.

Interpretation.

2. In this Schedule -

"**apiary**" means an establishment which keeps honeybees or bumble bees,

"**beehive**" means a container used for keeping honeybees or bumble bees,

"**unprocessed apiculture by-products**" means honey, beeswax, royal jelly, propolis or pollen not intended for human consumption as defined in point 10 of

Annex I to Commission Regulation (EU) No 142/2011 which have not undergone any processing procedure as referred to in Chapter II, Section 1, Table 2, Row 10 of the fourth column, of Annex XIV to that Regulation, and

"used beekeeping equipment" means used -

- (a) beehives,
- (b) parts of beehives, and
- (c) utensils used in an apiary."

EXPLANATORY NOTE

(This note is not part of this Order)

This Order amends the Import (Control) (Alderney) Order, 2010 to prohibit the importation of bees and related products originating in or dispatched from the Region of Calabria, Italy.

This Order comes into force on the 1st March, 2023.
