The Court of Appeal (Civil Division) (Guernsey) (Amendment) Rules, 2022

THE COURT OF APPEAL, in exercise of the powers conferred upon it by sections 22 and 44 of the Court of Appeal (Guernsey) Law, 1961^a, and all other powers enabling it in that behalf, hereby orders:-

Amendments to principal Rules.

1. The Court of Appeal (Civil Division) (Guernsey) Rules, 1964^b ("the principal Rules") are hereby amended as follows.

2. In rule 1(1) of the principal Rules –

(a) after the definition of "the Law" insert –

""official transcript" means the transcript of the record, or part thereof, made in accordance with section 23 of the Law", and

(b) the definition of "the shorthand writer" is revoked.

3. In rule 3 of the principal Rules –

(a) for "Every notice" substitute "Subject to rule 17(3), every notice", and

(b) for "one month" substitute "28 days".

4. In –

(a) rule 4(2)(b),

(b) rule 19(1)(b), and

(c) rule 21(a),

of the principal Rules, for "Clerk of the Court of Alderney" in each place where it occurs substitute "Alderney Greffier".

5. Rule 7 and rule 8(1)(g) of the principal Rules are revoked.

6. In rule 13(1)(c) of the principal Rules, for "and any four of" substitute "sitting with".

7. Part II of the Schedule to the principal Rules is revoked.

Interpretation.

8. In these rules "**the principal Rules**" means the Court of Appeal (Civil Division) (Guernsey) Rules, 1964.

Citation.

9. These rules may be cited as the Court of Appeal (Civil Division) (Guernsey) (Amendment) Rules, 2022.

Commencement.

10. These Rules shall come into force on the 7th February, 2022.
