**The Limited Partnerships (Guernsey) (Amendment)
Law, 2023 (Amendment and Commencement)

THE COMMITTEE FOR ECONOMIC DEVELOPMENT, in exercise of the powers conferred on them by sections 43 and 44 of the Limited Partnerships (Guernsey) Law, 1995^a, section 3 of the Limited Partnerships (Guernsey) (Amendment) Law, 2023^b, and all other powers enabling them in that behalf, and after consultation with the Guernsey Financial Services Commission, hereby makes the following Regulations:-

Amendment of Amendment Law.

1. (1) The Limited Partnerships (Guernsey) (Amendment) Law, 2023 is amended as follows.

- (2) In section 1(2), for "section 32HE" substitute "section 32HG".
- (3) In the provisions inserted by section 1(2) –
 - (a) section 32HF (disclosure of information by resident agent) is renumbered section 32HH,
 - (b) in renumbered inserted section 32HH (disclosure of information by resident agent), in paragraph (b) of subsection (4) at the end insert "of section 15(1)",
 - (c) section 32HG (disclosure of information by resident agent: supplementary) is renumbered section 32HI,
 - (d) in renumbered inserted 32HI (disclosure of information by resident agent: supplementary), in subsection (1) –
 - (i) for "in section 32HF(10)", substitute "in section 32HH(10)", and
 - (ii) for "under section 32HF", substitute "under section 32HH",
 - (e) section 32HI (tipping off) is renumbered section 32HJ,
 - (f) in renumbered inserted section 32HJ (tipping off), in subsection (1) for "under section 32HF" substitute "under section 32HH", and

(g) section 32HJ (privileged information) is renumbered section 32HK.

(4) In section 1(5), for "", 32HI(1)", substitute "", 32HJ(1)".

Amendment of Law.

2. (1) The Limited Partnerships (Guernsey) Law, 1995 is amended as follows.

(2) In section 8(2A), for "13th September" substitute "15th December".

(3) In subsection (1) of section 32HF (resignation of resident agent), both times they appear, for the words "registered agent" substitute the words "resident agent".

Commencement of Amendment Law.

3. The Limited Partnerships (Guernsey) (Amendment) Law, 2023 shall come into force on the 17th October 2023.

Citation.

4. These Regulations may be cited as the Limited Partnerships (Guernsey) (Amendment) Law, 2023 (Amendment and Commencement) Regulations, 2023.
