THE COMMITTEE FOR ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred upon it by sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007^a, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the Permits to Drive Public Service Vehicles Ordinance, 1986.

1. (1) The Road Traffic (Permits to Drive Public Service Vehicles) Ordinance, 1986^b is amended as follows.

(2) In section 4(4) -

- (a) in paragraph (a)(i) for "£70" substitute "£88",
 - (b) in paragraph (a)(ii) for "£10" substitute "£12.50", and
 - (c) in paragraph (b) for "£50" substitute "£63".
- (3) In section 7, for "£17" substitute "£21".
- (4) In the Schedule -
- (a) in relation to the fee to accompany an application, for "£10" substitute "£13.50",
 - (b) in relation to the fee for the grant of a 4 year permit, for "£20" substitute "£84", and
 - (c) in relation to the fee for the renewal of a 4 year permit, for "£40" substitute "£84".

Amendment of the Public Transport Ordinance, 1986.

2. (1) The Public Transport Ordinance, 1986^c is amended as follows.
- (2) In section 12 -
- (a) in subsection (1), for "£40" substitute "£50",
 - (b) in subsection (2), for "£17" substitute "£21", and

- (c) in subsection (3), for "£17" substitute "£21".
- (3) In section 14(3), for "£20" substitute "£25".
- (4) In section 42(6) -
 - (a) in paragraph (a), for "£30" substitute "£37.50",
 - (b) in paragraph (b), for "£50" substitute "£54", and
 - (c) in paragraph (c), for "£15" substitute "£16".

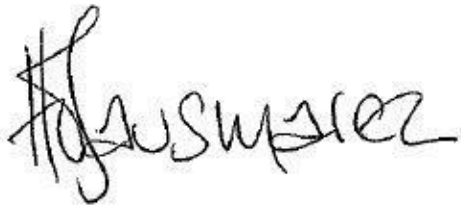
Citation.

EXPLANATORY NOTE

(This note is not part of the Regulations)

The Regulations amend the Road Traffic (Permits to Drive Public Service Vehicles) Ordinance, 1986 to increase the fees payable for a driving test to assess an applicant's ability to drive a public services vehicle, an Island knowledge test, and in respect of the application for or grant or renewal of a permit.

These Regulations also amend the Public Transport Ordinance 1986 to increase the fees for-

- (a) the grant or renewal of a public service vehicle licence,
- (b) the grant of a public service vehicle license on a temporary basis whilst a vehicle is undergoing repair,
- (c) the grant of a licence in respect of a vehicle which is to permanently replace a vehicle with an existing licence,
- (d) the transfer of a public service vehicle licence,
- (e) an application for a road service licence, or to vary such a licence, and
- (f) the examination of public service vehicles.

These Regulations come into force on 1st November, 2023.
