**The Motor Vehicles, Licensing, Tests and Traffic (Fees)
(Guernsey) Regulations, 2024**

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by sections 2A and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987^a, sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 1987^b, Article 2(2) of the Ordonnance relative aux Licences de Commerçant accordables à l'égard d'Automobiles en usage dans un but commercial, of 26th November 1932^c, section 1 of the Motor Vehicles (International Circulation) Ordinance, 1974^d, section 4A of the Driving Licences (Guernsey) Ordinance, 1995^e, sections 4, 5, 8, 9 and 16 of the Registration Marks (Sale and

Retention) Ordinance, 1997^f, and all other powers enabling them in that behalf, hereby makes the following Regulations:-

Registration marks.

1. (1) In Article 15(3)(b) of the Ordonnance supplémentaire à l'Ordonnance ayant rapport au Trafic Véhiculaire en cette Île, 1932^g (exchange of registration marks), for "£50" substitute "£55".

(2) The fees prescribed for the purposes of the Registration Marks (Sale and Retention) Ordinance, 1997 are as follows -

- (a) in section 4 (acquisition of right of retention), the sum of £110,
- (b) in section 5(1) (acquisition of right to reserve non-special registration mark), the sum of £110,
- (c) in section 8(1) and (3) (issue of duplicate certificate of entitlement), the sum of £55,
- (d) in section 9(5)(d) (extension of right), the sum of £110,

and for the purpose of those provisions these Regulations shall be deemed to be an Order of the Committee for the Environment & Infrastructure.

Fee for documents for drivers and motor vehicles going abroad.

2. For the purposes of section 1(4) of the Motor Vehicles (International Circulation) Ordinance, 1974 -

- (a) the fee prescribed for any document issued under section 1 of that Ordinance shall be £17, and
- (b) these Regulations shall be deemed to be an Order of the Committee for the Environment & Infrastructure.

Fees for trade plates.

3. In Article 2(2) of the Ordonnance relative aux Licences de Commerçant accordables à l'égard d'Automobiles en usage dans un but commercial, of 26th November 1932 -

- (a) for "£43", in both places it appears, substitute "£46", and
- (b) for "£20" substitute "£23".

Driving test and driving licence fees.

4. In the Driving Licences (Guernsey) Ordinance, 1995 -

- (a) in the table in Schedule 2, in the second column -
 - (i) for "£92", in each place it appears, substitute "£97", and
 - (ii) for "£159", in each place it appears, substitute "£169", and

(b) for the table in Schedule 3, substitute the table set out in the Schedule to these Regulations.

Fees for registration.

5. For the Table of fees in the Schedule to the Motor Taxation and Licensing (Fees) (Guernsey) Regulations, 2007^h substitute the following table -

Theory test fees.

6. In Schedule 1 of the Driving Licences (Theory Test) (Guernsey) Regulations 2016ⁱ, in Column 2 of the table -

(a) for "£47", in both places it appears, substitute "£50", and

(b) for "£67", in both places it appears, substitute "£71".

Revocation.

7. The Motor Vehicles, Licensing and Traffic (Fees) (Guernsey) Regulations, 2023^j are revoked.


Citation.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations increase the fees payable with effect from 4th March 2024 in relation to -

- the exchange and retention of registration marks,
- documents for drivers and motor vehicles going abroad,
- trade plate renewals,
- the issue and renewal of driving licences and of duplicate licences,
- first and subsequent registration of motor vehicles and the issue of duplicate registration certificates and certificates of export,
- driving tests and theory tests.

The amount to which each fee has been increased has been calculated to reflect the increase in RPIX since that fee was last increased, and rounded to the nearest £1.

These Regulations will come into force on the 4th March 2024.
