THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred on it by section 4 of the Criminal Justice (Miscellaneous Amendments – Deferred Prosecution Agreements) (Bailiwick of Guernsey) Ordinance, 2023^a, and all other powers enabling it in that behalf, hereby makes the following Regulations: -

Coming into force of 2023 Ordinance.

1. (1) Subject to paragraph (2), the Criminal Justice (Miscellaneous Amendments – Deferred Prosecution Agreements) (Bailiwick of Guernsey) Ordinance, 2023 ("**the Ordinance**") shall come into force on 26th April, 2024.

(2) To the extent that sections 1(2) and 1(3) of the Ordinance insert provisions into the Administration of Justice (Bailiwick of Guernsey) Law, 1991^b ("the Law") applying where D (within the meaning of the Schedule 1 inserted into the Law by the Ordinance) is an individual, sections 1(2) and 1(3) of the Ordinance shall not come into force.

Citation and commencement.

2. These Regulations may be cited as the Criminal Justice (Miscellaneous Amendments – Deferred Prosecution Agreements) (Bailiwick of Guernsey) Ordinance, 2023 (Commencement) Regulations, 2024, and shall come into force on being made.
