## The [Income Support (Guernsey) Law, 1971 (Commencement) Ordinance, 1971]

**THE STATES**, in exercise of the powers conferred upon them by section thirty-two of the [Income Support (Guernsey) Law, 1971]<sup>a</sup>, hereby order: –

### Commencement of Law of 1971.

1. The [Income Support (Guernsey) Law, 1971], shall come into force on the eleventh day of June, nineteen hundred and seventy-one.
