**The Public Transport (Fees) (Guernsey)
Regulations, 2024**

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred upon it by sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007^a, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the Road Traffic (Permits to Drive Public Service Vehicles) Ordinance, 1986.

1. (1) The Road Traffic (Permits to Drive Public Service Vehicles) Ordinance, 1986^b is amended as follows.

- (2) In section 4(4) –
 - (a) in paragraph (a)(i), for "£88" substitute "£92",
 - (b) in paragraph (a)(ii), for "£12.50" substitute "£14", and
 - (c) in paragraph (b), for "£63" substitute "£65.50".
- (3) In section 7, for "£21" substitute "£22.50".
- (4) In the Schedule -
 - (a) in relation to the fee to accompany an application, for "£13.50" substitute "£14",
 - (b) in relation to the fee for the grant of a 4 year permit, for "£84" substitute "£90", and
 - (c) in relation to the fee for the renewal of a 4 year permit, for "£84" substitute "£90".

Amendment of the Public Transport Ordinance, 1986.

- 2. (1) The Public Transport Ordinance, 1986^c is amended as follows.
- (2) In section 12 -
 - (a) in subsection (1), for "£50" substitute "£52.50",
 - (b) in subsection (2), for "£21" substitute "£22.50", and
 - (c) in subsection (3), for "£21" substitute "£22.50".

- (3) In section 14(3), for "£25" substitute "£26.50".
- (4) In section 42(6) -
 - (a) in paragraph (a), for "£37.50" substitute "£39.50",
 - (b) in paragraph (b), for "£54" substitute "£56", and
 - (c) in paragraph (c), for "£16" substitute "£16.50".


Citation.

EXPLANATORY NOTE

(This note is not part of the Regulations)

The Regulations amend the Road Traffic (Permits to Drive Public Service Vehicles) Ordinance, 1986 to increase the fees payable for a driving test to assess an applicant's ability to drive a public services vehicle, an Island knowledge test, and in respect of the application for or grant or renewal of a permit.

These Regulations also amend the Public Transport Ordinance 1986 to increase the fees for-

- (a) the grant or renewal of a public service vehicle licence,
- (b) the grant of a public service vehicle license on a temporary basis whilst a vehicle is undergoing repair,
- (c) the grant of a licence in respect of a vehicle which is to permanently replace a vehicle with an existing licence,
- (d) the transfer of a public service vehicle licence,
- (e) an application for a road service licence, or to vary such a licence, and
- (f) the examination of public service vehicles.

The amount to which each fee has been increased has been calculated to reflect the increase in RPIX since that fee was last increased, and rounded to the nearest £0.50.

These Regulations come into force on 19th November, 2024.
