**The Health Service (Payment of Authorised Appliance
Suppliers) (Amendment) Regulations, 2024**

Made 10th December, 2024

Coming into operation 1st January, 2025

Laid before the States , 2025

THE COMMITTEE FOR HEALTH & SOCIAL CARE, in exercise of the powers conferred on it by sections 19 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990^a, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the 2003 Regulations.

1. (1) The Health Service (Payment of Authorised Appliance Suppliers) Regulations, 2003^b ("**the principal Regulations**") are amended as follows.

(2) In the First Schedule to the principal Regulations, in the entry relating to a pharmacist not employed by a medical practice or the Committee for Health and Social Care, in the second column –

- (a) for "£3.66" in both places it occurs, substitute "£3.82",
and
 - (b) for "£1.84" substitute "£1.92".
- (3) In the Second Schedule to the principal Regulations, in the table
in Part II –
- (a) in the entry relating to a pharmacist not employed by a
medical practice or the Committee for Health and
Social Care, in the second column, for "78p" substitute
"82p", and
 - (b) in the entry relating to any other class of authorised
appliance supplier, for "78p" substitute "82p".
- (4) For the Third Schedule to the principal Regulations, substitute
the Schedule set out in the Schedule to these Regulations.

Citation, commencement and extent.

2. (1) These Regulations may be cited as the Health Service (Payment
of Authorised Appliance Suppliers) (Amendment) Regulations, 2024, and shall come
into force on the 1st January, 2025.

(2) These Regulations have effect in the Islands of Guernsey,
Alderney, Herm and Jethou.

Regulation 3

Additional dispensing fees payable in respect of Part I or Part II appliances supplied on an appliance prescription claim form endorsed "URGENT" or "DISPENSED URGENTLY" in accordance with Regulation 3 of these Regulations; or Part III and Part IV appliances supplied on an appliance claim form endorsed "DISPENSED URGENTLY".

Time of Supply	Dispensing fee
On any day, other than a non-business day, between the time the premises of the authorised appliance supplier are closed for the supply of medical appliances and 11pm.	£31.54
On a non-business day, between 9am and 11pm, except whilst the premises are open for the purposes of any scheme prepared by the Authority under Part II of the Schedule to the Health Service (Authorised Appliance Suppliers) Regulations, 1990.	£39.88
On any day between 11pm and 9am of the next day or such earlier time at which the premises are opened for the supply of medical appliances (on any day except a non-business day).	£103.54

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the First and Second Schedules to, and substitute the Third Schedule to, the Health Service (Payment of Authorised Appliance Suppliers) Regulations, 2003.

Those Schedules set out the payments which may be made out of the Guernsey Health Reserve for the supply of medical appliances.

These Regulations come into force on the 1st January, 2025.
