**The Health Service (Payment of Authorised Suppliers)  
(Amendment) Regulations, 2025**

THE COMMITTEE FOR HEALTH & SOCIAL CARE, in exercise of the powers conferred upon it by section 14 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990<sup>a</sup>, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendment of the 2003 Regulations.**

1. (1) The Health Service (Payment of Authorised Suppliers) Regulations, 2003<sup>b</sup> ("the principal Regulations") are amended as follows.

(2) In column 2 (dispensing fee) of the table in Part I of the First Schedule to the principal Regulations, for "£3.83" in both places it occurs, substitute "£3.82".

(3) In the Fifth Schedule to the principal Regulations –

(a) in the cross reference immediately following its title ("FIFTH SCHEDULE"), for "Regulations 4B and 4C", substitute "Regulations 4B, 4C and 4CA", and

(b) in the description of that schedule –

(i) for "and community packs", substitute ", community packs and administration systems", and

(ii) for "and 4C", substitute ", 4C and 4CA".

**Citation, commencement and extent.**

2. (1) These Regulations may be cited as the Health Service (Payment of Authorised Suppliers) (Amendment) Regulations, 2025, and shall come into force on the 14<sup>th</sup> January, 2025.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

#### **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the Health Service (Payment of Authorised Suppliers) Regulations, 2003 ("**the principal Regulations**") to correct minor errors.

Regulation 1(1) amends the First Schedule to substitute the dispensing fees payable in respect of pharmaceutical benefit where supplied by pharmacists not employed by a medical practice or the Committee for Health and Social Care. This corrects a one pence accounting error.

Regulation 1(2) amends the Fifth Schedule to the principal Regulations to correct cross-references to regulations in the principal Regulations.

These regulations will come into force on the 14<sup>th</sup> January, 2025.
