**The Minimum Wage (Accommodation and Food Offsets)
(Guernsey) (Amendment) Regulations, 2025**

12th March, 2025

Coming into operation

1st October, 2025

THE COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY, in exercise of the powers conferred on it by sections 2 and 31 of the Minimum Wage (Guernsey) Law, 2009^a, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Substitution of Schedule to principal Regulations.

1. The principal Regulations are further amended by substituting, for the Schedule to those Regulations, the schedule contained in the Schedule to these Regulations.

Interpretation.

2. In these Regulations, "**the principal Regulations**" means the Minimum Wage (Accommodation and Food Offsets) (Guernsey) Regulations, 2010^b.

Transitional and savings provisions.

3. (1) These Regulations do not have effect in relation to any worker and his or her work until the first day of the first pay reference period of the worker in respect of that work.

(2) For the avoidance of doubt, before the first day of the first pay reference period of the worker in respect of that work, the principal Regulations have effect in relation to that worker and that work as if these Regulations had not been made.

(3) In this regulation, "**the first pay reference period**", in relation to a worker and his or her work, means the first pay reference period of the worker, in respect of that work, beginning on or after the date specified in regulation 4 for these Regulations to come into force.

Citation and commencement.

4. These Regulations may be cited as the Minimum Wage (Accommodation and Food Offsets) (Guernsey) (Amendment) Regulations, 2025, and come into force on the 1st October, 2025.

SCHEDULE

Regulation 1

SCHEDULE TO BE SUBSTITUTED FOR THE SCHEDULE TO THE PRINCIPAL
REGULATIONS

"SCHEDULE
ACCOMMODATION AND FOOD OFFSETS

Regulations 1(2) and 2(2)

Maximum Accommodation and Meals Offset	£158 per week, or its equivalent prorated for the relevant pay reference period.
Maximum Accommodation Only Offset	£113 per week, or its equivalent prorated for the relevant pay reference period.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations replace the maximum accommodation and meals offset, and the maximum accommodation only offset, with the new maximum offsets of £158 per week and £113 per week, respectively, prorated for the relevant pay reference period, for the purposes of the Minimum Wage (Guernsey) Law, 2009.

These Regulations will come into force on the 1st October, 2025, and the new maximum offsets will take effect on and from the first day of the first pay reference period (as defined in regulation 3) of each worker in respect of any particular work.
