THE STATES OF ALDERNEY GENERAL SERVICES COMMITTEE, in exercise of the powers conferred upon it by sections 11 of the Alderney Road Traffic and Public Highways Ordinance, 1966a, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment to the Schedule.

1. For the Schedule to the Public Vehicle Regulations, 1990, there is substituted the following-
