**The Approved Warehouses (Bailiwick of Guernsey)  
(Amendment) Order, 2025**

**THE COMMITTEE FOR HOME AFFAIRS**, in exercise of the powers conferred upon it by sections 41 and 79 of the Customs and Excise (General Provisions) (Bailiwick of Guernsey) Law, 1972<sup>a</sup>, and all other powers enabling it in that behalf, hereby orders:-

**Amendment of the 2012 Order.**

1. (1) Schedule 1 to the Approved Warehouses (Bailiwick of Guernsey) Order, 2012<sup>b</sup> is amended as follows.

(2) In the table in that schedule-

- (a) in column 2 of row no. 2, for "Anglo Normandy Aero-engineering Limited", substitute "Aurigny Air Services Limited",
- (b) in column 2 of row no. 4, for "Wine and Beer Importers (Guernsey) Limited", substitute "Old Barn Airside (CI) Limited",
- (c) delete row no. 6 (naming E A Carey (Europe) Limited as proprietor),
- (d) delete row no. 12 (naming Wine and Beer Importers (Guernsey) Limited as proprietor), and
- (e) immediately after row no. 14, insert the following rows-

"15.	A specified area within the restricted port area reserved for vehicle check-in, St Peter Port Harbour, St Peter Port, Guernsey	Condor Limited
16.	A specified area within the Harbour passenger terminal, St Peter Port Harbour, St Peter Port, Guernsey	Condor Limited".

**Citation.**

2. This Order may be cited as the Approved Warehouses (Bailiwick of Guernsey) (Amendment) Order, 2025.

**Commencement.**

3. This Order shall come into force on the 15<sup>th</sup> April, 2025.
