**The Vaping Products (Guernsey) Ordinance
(Commencement) Order, 2025**

THE COMMITTEE FOR HEALTH & SOCIAL CARE, in exercise of the powers conferred upon it by section 59(1) of the Vaping Products (Guernsey) Ordinance, 2025^a, and all other powers enabling it in that behalf, hereby orders:-

Commencement of ban on sale or supply to children and other provisions.

1. (1) The following provisions of the Vaping Products (Guernsey) Ordinance, 2025 ("**the Ordinance**") shall come into force on the 1st June, 2025 -

- (a) section 25 (prohibition of sale or supply to children),
- (b) Schedule 3 (penalties for offences), to the extent that it relates to penalties for offences under section 25, and

- (c) any other provision of the Ordinance necessary to give effect to the provisions brought into force by subparagraph (a) or (b).

(2) The following provisions of the Ordinance shall also come into force on the 1st June, 2025 -

- (a) section 1 (object of this Ordinance),
- (b) section 22 (delegations by Committee or licensing officer),
- (c) the provisions of Part IV (enforcement and penalties), other than section 29(2)(a) (vape-licensed premises),
- (d) section 46 (Committee may further regulate vaping products),
- (e) section 47 (what constitutes reasonable steps to establish age),
- (f) section 48 (confidentiality),
- (g) section 49 (protection from self-incrimination),
- (h) section 50 (regulations and orders),
- (i) sections 52 (interpretation) and 53 (index of defined expressions),
- (j) section 55 (extent),

- (k) section 56 (exemption for certain vessels in territorial waters),
- (l) section 57 (citation),
- (m) section 59(1) (commencement of this Ordinance), and
- (n) the provisions of Schedule 2 (provisions for storage or disposal of seized property).

Citation.

2. This Order may be cited as the Vaping Products (Guernsey) Ordinance, (Commencement) Order, 2025.
