**The Driving Licences (Guernsey) (Amendment)  
Ordinance (Commencement) Order, 2025**

**THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE**, in exercise of the powers conferred on it by section 4 of the Driving Licences (Guernsey) (Amendment) Ordinance, 2025<sup>a</sup> and all other powers enabling it in that behalf, hereby orders:-

**Commencement of the 2025 Ordinance.**

1. The following provisions of the Driving Licences (Guernsey) (Amendment) Ordinance, 2025 shall come into force on the 1<sup>st</sup> October, 2025 -

- (a) sections 1 and 2 (amendment of Ordinance of 1995), to the extent that these insert into Schedule 1 to the Driving Licences (Guernsey) Ordinance, 1995<sup>b</sup> references to the following offences -

- (i) causing death by dangerous driving (an offence under section 1 of the Road Traffic (Causing Death or Serious Injury by Driving) (Guernsey) Law, 2025),
- (ii) causing death by careless or inconsiderate driving (an offence under section 2 of the Road Traffic (Causing Death or Serious Injury by Driving) (Guernsey) Law, 2025),
- (iii) causing serious injury by dangerous driving (an offence under section 3 of the Road Traffic (Causing Death or Serious Injury by Driving) (Guernsey) Law, 2025),
- (iv) causing serious injury by careless or inconsiderate driving (an offence under section 4 of the Road Traffic (Causing Death or Serious Injury by Driving) (Guernsey) Law, 2025),
- (v) dangerous driving (an offence under section 10(1) of the Road Traffic (Guernsey) Ordinance, 2019 committed after the commencement of the Road Traffic (Guernsey) (Amendment) Ordinance, 2025).

**Citation.**

2. This Order may be cited as the Driving Licences (Guernsey) (Amendment) Ordinance (Commencement) Order, 2025.

**EXPLANATORY NOTE**

This Order brings into force on the 1<sup>st</sup> October, 2025 provisions of the Driving Licences (Guernsey) (Amendment) Ordinance, 2025 ("**the 2025 Ordinance**") that insert in Schedule 1 to the Driving Licences (Guernsey) Ordinance, 1995 references to new dangerous or careless driving offences in the Road Traffic (Causing Death or Serious Injury by Driving) (Guernsey) Law, 2025) and the Road Traffic (Guernsey) Ordinance, 2019.
