The Plant Health (Brexit) (Amendment) (Guernsey) Regulations, 2020

THE POLICY & RESOURCES COMMITTEE, in exercise of the powers conferred on it by sections 5(1) and 11 of the European Union (Brexit) (Bailiwick of Guernsey) Law, 2018^a, and all other powers enabling it in that behalf, and upon receipt of the certificate required under section 5(3) of that Law, hereby makes the following Regulations: –

Amendment of the Preserved PHR.

1. (1) The Preserved PHR is amended, insofar as it applies to Guernsey, in the same way as the retained PHR is amended, as set out in Part 3 of the Plant Health (Amendment etc.) (EU Exit) Regulations 2020^b ("**the GB Plant Health Regulations**"), except for those terms, expressions or provisions set out in the first column of the Table in Schedule 1 which are varied from the retained PHR as set out in the corresponding row in the second column of the Table in Schedule 1.

(2) Any variation provided for in paragraph (1) which applies to each reference to the relevant term or expression in the retained PHR shall also apply to each reference to the same term or expression in any retained Schedule 3 item.

(3) For the avoidance of doubt, any variation provided for in paragraph (1) or (2) which applies to each reference to the relevant term or expression in the retained PHR or any retained Schedule 3 item is subject to any specific variation to a particular Article or other provision of the retained PHR or the retained

Schedule 3 item, as the case may be, provided for in paragraph (1) or regulation 3.

Amendment of the Preserved Phytosanitary Conditions Regulation.

2. (1) The Preserved Phytosanitary Conditions Regulation is amended, insofar as it applies to Guernsey, in the same way as the retained Phytosanitary Conditions Regulation, as set out in Part 2 of the Plant Health (Phytosanitary Conditions) (Amendment) (EU Exit) Regulations 2020 ("**the GB Phytosanitary Conditions Regulations**"), except for those terms, expressions or provisions set out in the first column of the Table in Schedule 2 which are varied from the retained Phytosanitary Conditions Regulation as set out in the corresponding row in the second column of the Table in Schedule 2.

(2) For the avoidance of doubt, any variation provided for in paragraph (1) which applies to each reference to the relevant term or expression in the retained Phytosanitary Conditions Regulation is subject to any specific variation to a particular Article or other provision of the retained Phytosanitary Conditions Regulation provided for in paragraph (1).

Amendment of other Preserved EU law.

3. (1) Each Preserved Schedule 3 item is amended, insofar as the item applies to Guernsey, in the same way as the retained Schedule 3 item of the same title is amended, as set out in Part 3 of the GB Plant Health Regulations, except for –

- (a) any terms or expression in a retained Schedule 3 item varied in accordance with regulation 1(2), and
- (b) any further variations, from the retained Schedule 3 item set out in respect of that item in Part II of Schedule 3.

Amendment of the Plant Health (Implementation) (Guernsey) Ordinance.

4. (1) The Plant Health (Implementation) (Guernsey) Ordinance, 2020^c is amended as follows.

(2) For each reference to –

- (a) "an EU plant health rule" or "EU plant health rule" substitute "a plant health rule" or "plant health rule" respectively,
- (b) "the Union territory" substitute "Guernsey", and
- (c) "plant passport" substitute " UK plant passport".

(3) In section 3(1)(c) and 4(c), for "the Union territory" substitute "the Bailiwick".

(4) In section 7 (introduction) –

- (a) in subsection (2)(b), omit "the Union territory or", and
- (b) in subsection (2)(c), omit "within the Union territory or".

(5) In sections 9(3) and 24(4) omit "(including representatives of the European Commission)".

(6) Part IV (temporary local measures) is repealed.

(7) In section 14 (applications for authorisation or for the issue of a phytosanitary certificate etc.) –

- (a) in subsection (1)(e), for the comma substitute "or" and omit "or a pre-export certificate", and
- (b) in subsection (2), in the definition of "relevant activity", omit ", an EU emergency decision".

(8) In section 15 (authorisations for other purposes) –

- (a) in subsection (1) –
 - (i) omit "the carrying out of" and insert those words at the start of paragraphs (a) and (b),
 - (ii) immediately after paragraph (a), omit "or" and insert the following paragraph –

"(ab) the introduction into Guernsey, the movement within Guernsey, or the holding or multiplication in Guernsey, of a potential quarantine plant pest for official testing, scientific or educational purposes, trials, varietal selection or breeding, or",

- (b) for subsection (3), substitute –

" (3) In this section –

"a plant health derogation" means a derogation from provisions of the PHR which is set out in Preserved EU law, an enactment implementing the same or regulations made under the PHR or the OCR, and

"potential quarantine plant pest" means a plant pest which is not a Guernsey quarantine pest or a provisional Guernsey quarantine pest, but which, in the opinion of the appropriate authority, fulfils the criteria set out in subsection 1 of Section 3 of Annex I to the PHR or may fulfil the criteria in subsection 2 of that Section."

(9) In section 16 (registrations made or authorisations granted by the Committee), in the words before paragraph (a), for ", the OCR or" substitute "or the OCR or under".

(10) In section 17(2) (fee for issue of phytosanitary certificates etc.)

–

(a) immediately after paragraph (a), insert "and", and

(b) immediately after paragraph (b) omit "and", and

(c) omit paragraph (c).

(11) Sections 18 (notification requirements in relation to seed potatoes) and 19 (notifications in relation to citrus fruits) are repealed.

(12) In section 20 (notification requirements in relation to other plants and plant products) –

- (a) in subsection (1) –
 - (i) omit "any of the following plants or plant products",
 - (ii) after "into Guernsey" insert "any solid fuel wood from a third country to which Article 47(1) of the OCR does not apply",

- (b) in subsection (2) –
 - (i) in paragraphs (c) and (d) omit "plants or",
 - (ii) in paragraph (d), for "have been, or are" substitute "has been, or is",

 - " (f) the address of the consignor, and

- (13) In section 21 (powers of entry) –

(15) In section 28 (disclosure of information to other competent authorities), for "Union territory" substitute "British Islands, which is responsible for plant health rules,".

(16) In section 34(1) (general (relating to offences)) –

(a) omit paragraphs (a) and (f), and

(b) in paragraph (b), omit "18(1) or 19(1) or",

(17) In section 37(2) (provision of false or misleading information), for the words "for export" to the end substitute "for export or a phytosanitary certificate for re-export".

(18) In section 39 (obstruction) –

(a) renumber the current text as subsection (1),

(b) in paragraphs (a) and (c) after "enforcement of" insert "any provision under", and

(c) after subsection (1) insert –

" (2) In subsection (1), a reference to the PHR or the OCR includes Preserved EU law adopted, or regulations made, under the PHR or the OCR and any other Preserved EU law or enactment implementing the same relating to plant health."

(19) In section 48(1) (interpretation: general) –

(a) omit the definitions of "another member State", "EU emergency decision", "Spain" and "Union territory",

(b) in the definition of "controlled consignment" –

(i) in paragraph (a)(i) for "protected zone" substitute "Guernsey pest-free area", and

(ii) omit paragraph (a)(ii),

(c) in the definition of "**controlled plant pest**" –

(i) in paragraph (a), for "Annex II, III or IV" substitute "Annex 2, 2A, 3 or 4",

(ii) immediately after paragraph (a), insert "or", and

(iii) omit paragraph (b) and the "or" immediately after it,

(d) after the definition of "**premises**" insert –

" "**Preserved EU law**" has the meaning given in section 3(1) of the European Union (Brexit) (Bailiwick of Guernsey) Law, 2018," and

(e) in the definition of "third country" for "Union territory" substitute "British Islands".

(20) Sections 49 (Interpretation: EU instruments relating to plant health) and 50 (measures adopted under Article 30(1) of the PHR) are repealed.

(21) Schedule 1 (temporary local measures) is repealed.

(22) In the heading to Schedule 2 for "the EU Regulations" substitute "Preserved EU law".

(23) In the table in Part I (the PHR) of Schedule 2 (offences; relevant provisions in the EU Regulations) –

(a) for each reference to "certain protected zones" substitute "Guernsey pest-free areas",

(b) for each reference to "Union quarantine pest" substitute "Guernsey quarantine pest",

(c) for each reference to "protected zone quarantine pest" substitute "PFA quarantine pest",

(24) In the table in Part II (the OCR) of Schedule 2 in the entries relating to Articles 47(5) and 56(4), for each reference to "the Union" substitute "Guernsey".

(25) Schedule 3 (offences relating to EU Emergency Decisions) is repealed.

Interpretation.

5. In these Regulations, unless the context requires otherwise –

"the GB Plant Health Regulations": see regulation 1(1),

"the GB Phytosanitary Conditions Regulations": see regulation 2(1),

"the Preserved PHR" means the item of Preserved EU law entitled Regulation (EU) 2016/2031 of the European Parliament and of the Council on

protective measures against pests of plants^d,

"the Preserved Phytosanitary Conditions Regulation" means the item of Preserved EU law entitled Commission Implementing Regulation (EU) 2019/2072 establishing uniform conditions for the implementation of Regulation (EU) 2016/2031 of the European Parliament and the Council, as regards protective measures against pests of plants^e,

"Preserved Schedule 3 item" means an item of Preserved EU law listed in Part I of Schedule 3,

"the retained PHR" means the item of retained EU law entitled Regulation (EU) 2016/2031 of the European Parliament and of the Council on protective measures against pests of plants^f,

"the retained Phytosanitary Conditions Regulation" means the item of retained EU law entitled Commission Implementing Regulation (EU) 2019/2072 establishing uniform conditions for the implementation of Regulation (EU) 2016/2031 of the European Parliament and of the Council, as regards protective measures against pests of plants^g,

"retained Schedule 3 item" means an item of retained EU law of the same title as an item of Preserved EU law listed in Part I of Schedule 3,

"retained EU law" has the meaning in section 6(7) of the European

Union (Withdrawal) Act 2018^h,

"**variation**" means a substitution, omission, construction or other variation,

and other terms or expressions, unless the context requires otherwise, shall have the same meaning as in the Preserved PHR.

Transitional provision: plants, plant products and other objects from EU Member states.

6. [(1) This regulation applies to plants, plant products and other objects which –

(a) originate in, or are dispatched from, an EU Member State, Liechtenstein or Switzerland, and

[(b) are introduced into Guernsey during the period commencing on 4th March, 2024 and ending on [31st January, 2027].]]

(2) In relation to plants, plant products and other objects to which this regulation applies –

[(a) Article 72(1) of the Preserved PHR does not apply in relation to plants which –

(i) are of a kind not listed in Schedule 4, and

(ii) meet the conditions specified in paragraph (2A) or (2B), and]

(b) Article 73(1) of the Preserved PHR does not apply.

[(2A) The conditions specified in this paragraph are that the plants –

(a) are introduced into Guernsey as part of a traveller's personal luggage, and

(b) are not to be used for professional or commercial purposes.

(2B) The condition specified in this paragraph is that the plants are of a category specified in column 1, and of a description specified in the corresponding entry in column 2, of the table in Schedule 4A.

(2C) Article 72(1) does not apply in relation to plants, plant products or other objects of a kind other than those listed in Schedule 4 which are dispatched from an EU Member State, Liechtenstein or Switzerland before 4th March 2024.]

(3) ...

NOTES

In regulation 6,

first, paragraph (1) and, second paragraph (2)(a) were substituted, third, paragraphs (2A), (2B) and (2C) were inserted and, fourth, paragraph (3) was revoked by the Plant Health (Amendment of Transitional Provision) (Guernsey) Regulations, 2024, respectively regulation 1(2)(a), regulation 1(2)(b), regulation 1(2)(c) and regulation 1(2)(d), with effect from 4th March, 2024;¹

Transitional provision: UK plant passports.

7. (1) An authorisation to issue plant passports which has been granted and has effect immediately before exit day continues to apply after exit day as if it were an authorisation to issue UK plant passports.

(2) In the case of any plant passport that has been issued in respect of any plant, plant product or other object before exit day for the purposes of the movement of that plant, plant product or other object which takes place in part before and in part after exit day, the plant passport is after exit day to be treated as if it were a UK plant passport and references to a UK plant passport are to be construed accordingly.

(3) In this regulation –

"**plant passport**" has the meaning given in Article 78 of Regulation (EU) 2016/2031 of the European Parliament and of the Council on protective measures against pests of plants as it has effect, as from time to time amended, in EU law^j, and

"**UK plant passport**" has the meaning given in Article 78 of the Preserved PHR.

Disapplication of items of Preserved EU Law.

8. The items of Preserved EU law listed in Schedule 5 are disapplied, insofar as they apply to Guernsey –

- (a) to the extent that equivalent provision is made under the Preserved PHR, other Preserved EU law or the Plant Health (Implementation) (Guernsey) Ordinance, 2020 ("**Implementation Ordinance**"), and
- (b) from the date that the equivalent provision under the Preserved PHR, other Preserved EU law or the Implementation Ordinance comes into force.

Savings.

9. (1) The disapplication of the items of Preserved EU law listed in Schedule 5 and the amendments to the Preserved PHR have no effect on the validity of any notice issued or any licence, authorisation or other approval given under or for the purposes of –

- (a) any EU instrument, of the same title as any item of Preserved EU law listed in Schedule 5, as that EU instrument had effect in Guernsey before exit day, or
- (b) Regulation (EU) 2016/2031 of the European Parliament and of the Council on protective measures against pests of plants^k as it had effect in Guernsey before exit day.

(3) Any such notice, licence, authorisation or other approval remains in force and continues to have effect on or after exit day in so far as it applies to anything done, or omitted to be done, before or after exit day.

- (4) Paragraph (1) is subject to regulation 7.

Extent.

10. These Regulations have effect in the islands of Guernsey, Herm and Jethou.

Citation.

11. These Regulations may be cited as the Plant Health (Brexit) (Amendment) (Guernsey) Regulations, 2020.

Commencement.

12. These Regulations shall come into force on exit day.

EXPLANATORY NOTE

*(This note is not part of the Regulations)***

These Regulations are made under the European Union (Brexit) (Bailiwick of Guernsey) Law, 2018 and make provision which is necessary or expedient as a result of the withdrawal of the United Kingdom from the EU.

The Regulations make amendments to EU provisions which have effect in Guernsey in the field of plant health including in particular to the Plant Health Regulation relating to protective measures against plant pests (PHR), and the Phytosanitary Conditions Regulation, made under the PHR (see Regulations 1 and 2). The Regulations also make consequential amendments to the Plant Health (Implementation) (Guernsey) Ordinance, 2020 which provides for administrative, enforcement and appeal provisions in Guernsey in relation to the PHR (see Regulation 4).

The amendments are primarily made to reflect that from the end of 2020 Guernsey will cease to be subject to EU law in relation to trade in plants and plant products and will be part of a Great Britain and Crown Dependency market in such products.

Amendments include replacement of the previous plant passports, required to accompany movements of certain plants within the EU, by UK plant passports for movements within Great Britain and the Crown Dependencies. Previous functions of the European Commission under the PHR to make delegated legislation on points of technical detail are conferred on the Committee for the Environment & Infrastructure including powers to amend by Regulations lists of plant pests, plants and plant products vulnerable to those pests, requirements to be met in relation to movements of such vulnerable plants and plant products and of pest-free areas. Amendments are also made to replace those technical lists, previously set at EU level, for Guernsey lists.

The amendments are made to align with proposed amendments in Great Britain to plant health legislation of EU origin to ensure equivalent plant health rules operate in the new market. Transitional and savings provisions are also included to ensure a smooth transition to the amended requirements (see Regulations 6, 7 and 9). These include provision for reduced requirements to apply to plants and plant products originating or dispatched from the EU up until the end of March, 2021 and to allow plant passports issued under the EU provisions to be treated as UK plant passports. Certain current EU legislation is disapplied; most relate to specific measures against

pests from certain third countries in relation to which measures can be taken under the PHR as amended (see Regulation 8).

These Regulations come into force on exit day within the meaning of the European Union (Brexit) (Bailiwick of Guernsey) Law, 2018.
