

STATUTORY INSTRUMENT**No 8 of 2025****The Import (Control) (Alderney) (Amendment) (No 7) Order, 2025**

THE STATES OF ALDERNEY POLICY AND FINANCE COMMITTEE, in exercise of the powers conferred on it by article 1 of the Import and Export (Control) (Alderney) Law, 1946a and of all other powers enabling it in that behalf, hereby makes the following order:-

Amendment of the Import (Control) (Alderney) Order, 2010.

1. (1) Schedule 11 to the Import (Control) (Alderney) Order, 2010b is amended as follows.

(2) In the table in that schedule -

(a) in each of entries 3 and 4, in Column 2 -

(i) delete "Austria,"

(ii) for "any of these countries have", substitute "either country has", and

(iii) for "the Department for Environment, Food & Rural Affairs of the United Kingdom", substitute "DEFRA",

(b) in entry 5 -

(i) in Column 1, in paragraph (1)(c), for the part of this item beginning with "those referred to" and ending with "are concerned," substitute -

"the following -

(i) those referred to in paragraph (1) of Section 5 of Chapter II of Annex 14 to Regulation 142/2011,

(ii) those -

(A) immersed in boiling water for an appropriate time so as to ensure that any matter other than bone, horns, hooves, claws, antlers or teeth is removed, and

(B) disinfected with hydrogen peroxide where parts consisting of bone are concerned,"

(ii) in Column 1, in paragraph (1)(f), for ", unless it is extruded dry pet food or", substitute "or extruded dry pet food, unless",

(iii) in Column 1, immediately after paragraph (1)(g), insert the following item -

- "(h) blood products from ungulates, unless subjected to one of the following treatments -
- (i) heat treatment at a temperature of 65°C for at least three hours, followed by an effectiveness check,
 - (ii) irradiation at 25 kGy by gamma rays, followed by an effectiveness check,
 - (iii) for susceptible species other than *Suidae* or *Tayassuidae*, a change in pH to pH 5 for two hours, followed by an effectiveness check,
 - (iv) heat treatment of at least 80 °C throughout their substance, followed by an effectiveness check."

(iv) in Column 2 -

- (A) delete "Austria",
- (B) for "any of these countries have", substitute "either country has", and
- (C) for "the Department for Environment, Food & Rural Affairs of the United Kingdom", substitute "DEFRA",

(c) in entry 6, in column 2, for" Austria or any country or territory that is not an FFMD country or territory.", substitute the following-

"Any country or territory, except -

- (a) a country or territory listed in Annex 1 to the Wool and Hair Declaration, or
 - (b) an FMD-free zone listed in Annex 2 to the Wool and Hair Declaration.",
- (d) in entry 7 -
- (i) in Column 1, immediately after "2025", insert ("**the Wool and Hair Declaration**")", and
 - (ii) in Column 2, for "An FFMD country or territory, other than Austria.", substitute "An FMD-free zone listed in Annex 2 to the Wool and Hair Declaration.",
- (e) in entry 11, in Column 2, in the definition of "**milk**" in paragraph (3), for "Commission Regulation (EU) No 605/2010 of 2 July 2010 laying down animal and public health and veterinary certification conditions for the introduction into the European Union of raw milk and dairy products intended for human consumption", substitute "Commission Regulation (EU) No 605/2010", and
- (f) immediately after entry 14, insert the following entry-

15.	(a) Hides and skins of bovine animals, except if subjected to any of the following treatments- (i) dry-salted or wet-salted for a period of at least 14 days prior to dispatch,	Italy or France

(3) In the Interpretation part of the Schedule, insert the following definitions in the appropriate alphabetical order -

""blood products" means products derived from blood or fractions of blood, excluding blood meal, including dried, frozen or liquid plasma, dried whole blood, dried, frozen or liquid red cells or fractions thereof and mixtures,"

""DEFRA" means the Department for Environment, Food & Rural Affairs of the United Kingdom,"

""pasteurisation"" means the process by which milk is exposed to a single heat treatment with a heating effect at least equivalent to that achieved by a pasteurisation process of at least 72QC for 15 seconds and, where applicable, sufficient to ensure a negative reaction to an alkaline phosphatase test applied immediately after the heat treatment,"

""Regulation (EU) No 605/2010"" means Commission Regulation (EU) No 605/2010 of 2 July 2010 laying down animal and public health and veterinary certification conditions for the introduction into the European Union of raw milk and dairy products intended for human consumption,"

""the Wool and Hair Declaration"": see entry 7,"

Citation.

2. This Order may be cited as the Import (Control) (Alderney) (Amendment) (No. 7) Order, 2025.

Commencement.

3. This Order shall come into force on the 6th August, 2025.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends Schedule 11 to the Import (Control) (Alderney) Order, 2010 to update import restrictions imposed to prevent foot and mouth disease, and impose restrictions on the importation of certain hides, skins, animal by-products and milk-related products originating in Italy or France to prevent lumpy skin disease.

This Order comes into force on the 6th August, 2025.
