THE COMMITTEE FOR ECONOMIC DEVELOPMENT, in exercise of the powers conferred on it by sections 9, 11, 27, 37, 46, 111 and 113 of the Limited Liability Partnerships (Guernsey) Law, 2013^a, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the Limited Liability Partnerships (Fees) Regulations, 2014.

1. (1) The Limited Liability Partnerships (Fees) Regulations, 2014^b are amended as follows.

(2) For the Schedule, substitute the Schedule set out in the Schedule to these Regulations.

2. These Regulations may be cited as the Limited Liability Partnerships (Fees) (Amendment) Regulations, 2025.
