THE COMMITTEE FOR ECONOMIC DEVELOPMENT, in exercise of the powers conferred upon it by section 51, paragraphs 3(2), 7(6), 7(7) and 10(2) of Schedule 1, and paragraphs 4(2) and 12(2) of Schedule 2 of the Foundations (Guernsey) Law, 2012^a ("**the Law**"), and by section 501 of the Companies (Guernsey) Law, 2008^b, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the Foundations (Fees) (Guernsey) Regulations, 2013.

1. (1) The Foundations (Fees) (Guernsey) Regulations, 2013^c are amended as follows.

(2) For the Schedule, substitute the Schedule set out in the Schedule to these Regulations.

2. These Regulations may be cited as the Foundations (Fees) (Guernsey) (Amendment) Regulations, 2025.

Commencement.

3. These Regulations shall come into force on the 1st day of December, 2025.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Foundations (Fees) (Guernsey) Regulations, 2013 to substitute the Schedule and specify the fees, and the person by whom and time by when they are payable, for applications to and the exercise of the functions of the Registrar of Foundations under the Foundations (Guernsey) Law, 2012.

These Regulations come into force on the 1st of December, 2025
