**The Limited Partnerships (Fees) (Amendment)  
Regulations, 2025**

THE COMMITTEE FOR ECONOMIC DEVELOPMENT, in exercise of the powers conferred on it by sections 36(1)(c), 43 and 44 of the Limited Partnerships (Guernsey) Law, 1995<sup>a</sup>, and all other powers enabling it in that behalf, and after consultation with the Guernsey Financial Services Commission, hereby makes the following Regulations:-

**Amendment of the Limited Partnerships (Fees, Annual Validations and Miscellaneous Provisions) Regulations, 2016.**

1. (1) The Limited Partnerships (Fees, Annual Validations and Miscellaneous Provisions) Regulations, 2016<sup>b</sup> are amended as follows.

(2) For the Schedule, substitute the Schedule set out in the Schedule to these Regulations.

**Amendment of section 36 of the Limited Partnerships (Guernsey) Law, 1995.**

2. (1) Section 36(1) of the Limited Partnerships (Guernsey) Law, 1995 ("the Law") is amended as follows.

(2) For paragraph (a)(i) substitute -

"(i) a declaration under section 8(2)(d) -

(A) a fee of £500, where fast track registration of the partnership (within 2 hours) is requested, or

(B) a fee of £100, where standard registration of the partnership (within 24 hours) is requested,".

(2) For paragraph (a)(ii) substitute -

"(ii) notice of change of particulars or of general partners under section 10(1), the fee specified in regulation 3 of the Limited Partnerships (Fees) Regulations, 2025,".

(3) In paragraph (a)(iii), for "£25" substitute "£15".

(4) In paragraph (a)(iv), for "£25" substitute "£15".

**Fees payable upon filing of notice of change of particulars or of general partners**

3. (1) For the purposes of section 36(1)(a)(ii) of the Law, the fee specified as payable upon filing of a notice of change of particulars or of general partners under section 10(1) of the Law shall be -

- (a) £50, where there is a change in the particulars of the governance provisions of the partnership agreement referred to in section 8(2)(b) of the Law,
- (b) £25, where there is a change is to the name of the partnership referred to in section 8(2)(d)(i) of the Law,
- (c) £25, where there is a change to -
  - (i) the principal place of business of the partnership referred to in section 8(2)(d)(ii) of the Law, or
  - (ii) the partnership's registered office referred to in section 8(2)(d)(iii) of the Law,
- (d) £15, where there is a change to the particulars of the general partners referred to in section 8(2)(d)(iv) of the Law, and
- (e) £15, where there is a change to any registered particulars not referred to in subparagraphs (a) - (d).

(2) For the avoidance of doubt, where a notice is filed of a change in more than one registered particular the fee payable under paragraph (1) shall be the total of each of the applicable fees specified in subparagraphs (a) to (e).

**Citation.**

4. These Regulations may be cited as the Limited Partnerships (Fees) (Amendment) Regulations, 2025.

**Commencement.**

5. These Regulations shall come into force on the 1<sup>st</sup> day of December, 2025.

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations, made under the Limited Partnerships (Guernsey) Law, 1995, amend the Limited Partnerships (Fees, Annual Validations and Miscellaneous Provisions) Regulations, 2016, by substituting the Schedule of fees payable to the Registrar of Companies in respect of services in relation to limited partnerships. They also amend the fees payable to the Registrar of Companies under section 36 of the Limited Partnerships (Guernsey) Law, 1995 upon the filing of certain documents by limited partnerships.

These Regulations come into force on the 1<sup>st</sup> day of December, 2025.
