THE REGISTRAR OF LIMITED LIABILITY PARTNERSHIPS, in exercise of the powers conferred on her by sections 8, 67, and 113 of, and Schedule 1 to the Limited Liability Partnerships (Guernsey) Law, 2013<sup>a</sup> ("the Law"), by section 501 of the Companies (Guernsey) Law, 2008<sup>b</sup>, and all other powers enabling her in that behalf, and after having consulted with the Committee for Economic Development in respect of the exercise of her powers under section 8(3) of the Law, hereby makes the following Regulations:-

(2) For Schedule 1, substitute the Schedule 1 set out in the Schedule to these Regulations.


**Citation.**

## EXPLANATORY NOTE

*(This note is not part of the regulations)*

These Regulations, made by the Registrar of Limited Liability Partnerships ("**the Registrar**"), amend the Limited Liability Partnerships (Registrar) (Fees and Penalties) Regulations, 2014 by substituting Schedule 1 specifying the fees payable for applications to, and the exercise of the functions of, the Registrar under the Limited Liability Partnerships (Guernsey) Law, 2013.

These regulations come into force on the 1<sup>st</sup> of December, 2025.
