The Health Service (Pharmaceutical Benefit and Medical Appliances) (Amendment) Regulations, 2025

THE COMMITTEE FOR HEALTH & SOCIAL CARE, in exercise of the powers conferred upon it by sections 13, 18 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990^a, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of 1990 Ordinance.

1. For Schedule I to the Health Service (Benefit) Ordinance, 1990^b, substitute the Schedule set out in Schedule 1 to these Regulations.

Amendment of 1990 Regulations.

2. For the Third Schedule to the Health Service (Medical Appliances) Regulations, 1990^c, substitute the Schedule set out in Schedule 2 to these Regulations.

Revocation.

3. The Health Service (Pharmaceutical Benefit and Medical Appliances) (Amendment) Regulations, 2024^d are revoked.

Citation.

4. These Regulations may be cited as the Health Service (Pharmaceutical Benefit and Medical Appliances) (Amendment) Regulations, 2025.

Commencement.

5. These Regulations come into force on 1st January, 2026.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Health Service (Benefit) Ordinance, 1990 in relation to prescription charges for items of pharmaceutical benefit (drugs and medicines) and the Health Service (Medical Appliances) Regulations, 1990 in relation to charges payable to authorised appliance suppliers in Guernsey and Alderney by persons supplied with Part I, II or III medical appliances, who are not exempt from such charges. These amendments have effect from 1st January, 2026 and from that date charges will increase from £5.20 to £5.40 per item or appliance.

The Regulations come into force on the 1st January, 2026.
