THE POLICY & RESOURCES COMMITTEE, in exercise of the powers conferred upon it by sections 60 and 66 of the Marriage (Bailiwick of Guernsey) Law, 2020^a, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendments to the 2020 Regulations.

1. (1) The Marriage (Bailiwick of Guernsey) Regulations, 2020^b ("the 2020 Regulations") are amended as follows.

(2) For Schedule 2 to the 2020 Regulations, substitute the Schedule 2 set out in the Schedule to these Regulations.

Revocations.

2. The following enactments are revoked –

Citation.

3. These Regulations may be cited as the Marriage (Bailiwick of Guernsey) (Amendment) (No. 2) Regulations, 2025.

Commencement.

4. These Regulations shall come into force on the 1st January, 2026.
