**The Public Records (Fees for Registration and Certified  
Copies of Documents) Regulations, 2025**

THE POLICY & RESOURCES COMMITTEE, in exercise of the powers conferred upon it by sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007<sup>a</sup>, section 20(c) of the Interpretation and Standard Provisions (Bailiwick of Guernsey) Law, 2016<sup>b</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendments to the Ordinance.**

1. (1) The Public Records (Fees for Registration and Certified Copies of Documents) Ordinance, 1960<sup>c</sup> is amended as follows.

- (2) In section 1 –
- (a) in paragraph (a), for "£80" substitute "£83",
  - (b) in paragraph (b), for "£7" substitute "£8", and
  - (c) in paragraph (c), for "£7" substitute "£8".
- (3) In section 2 –
- (a) in paragraph (a), for "£30" substitute "£31", and
  - (b) in paragraph (b), for "£7" substitute "£8".
- (4) In section 2A, for "by His Majesty's Greffier" to the end, substitute –

"by His Majesty's Greffier –

- (a) a fee of £5.00 for each page or part of a page (in the case of an A4 monochrome copy),
  - (b) a fee of £6.00 for each page or part of a page (in the case of an A3 monochrome copy),
  - (c) a fee of £7.00 for each page or part of a page (in the case of an A4 colour copy), and
  - (d) a fee of £8.00 for each page or part of a page (in the case of an A3 colour copy)."
- (5) In section 2B, in paragraphs (a) and (b), for "£68" in each place it occurs substitute "£71".

**Revocations.**

2. The Public Records (Fees for Registration and Certified Copies of Documents) Regulations, 2023<sup>d</sup> are revoked.

**Citation.**

3. These Regulations may be cited as the Public Records (Fees for Registration and Certified Copies of Documents) Regulations, 2025.

**Commencement.**

4. These Regulations shall come into force on the 1<sup>st</sup> January, 2026.

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations amend the Public Records (Fees for Registration and Certified Copies of Documents) Ordinance, 1960.

The fees in section 1 (registration fees for documents), section 2 (fees for copies of documents registered) and section 2B (fees in respect of documents creating charge on land) have been increased.

Section 2A (fees for uncertified copies of documents registered) has been amended to increase the fee payable per page, dependant on the page size and whether the document is monochrome or in colour.

These Regulations come into force on the 1<sup>st</sup> January, 2026.
