(AMENDMENT) RULES, 2025**

The Capacity (Lasting Powers of Attorney) (Appeals, etc.) (Amendment) Rules, 2025

THE ROYAL COURT, in exercise of the powers conferred upon it by section 83 of the Capacity (Bailiwick of Guernsey) Law, 2020^a, section 20(c) of the Interpretation and Standard Provisions (Bailiwick of Guernsey) Law, 2016^b, and all other powers enabling it in that behalf, hereby orders:-

Amendment to Rules.

1. (1) The Capacity (Lasting Powers of Attorney) (Appeals, etc.) Rules, 2022^c ("the principal Rules") are amended as follows.

(2) In the principal Rules, for "Her Majesty's Greffier", wherever it occurs, substitute "His Majesty's Greffier".

(3) In rule 2, for "Part 1" substitute "Part I".

(4) In rule 5(2), renumber subparagraph (f) as subparagraph (e).

(5) In rule 7 –

(a) in paragraph 1(a) –

(i) in item (i), for "£88" substitute "£91",

- (e) in paragraph (3), for "£22" substitute "£23".

Repeals.

2. The Capacity (Lasting Powers of Attorney) (Appeals, etc.) (Amendment) Rules, 2023^d are repealed.

Citation.

3. These Rules may be cited as the Capacity (Lasting Power of Attorney) (Appeals, etc.) (Amendment) Rules, 2025.

Commencement.

4. These Rules come into force on the 1st January, 2026.
